Subject: Clarification of HEC Recognized Journals

In continuation to HEC letter No: Misc/RJS/R&D/HEC/22/11 dated April 19, 2022 addressed to the Acting Registrar, COMSATS University Islamabad regarding clarification on publication requirements for faculty appointment, promotion and award of PhD research work under HJRS. It has been noticed that since the issuance of the said letter particularly clause (v), various stakeholders in the universities have been asking about the benefits associated with Y-Category journals.

2. The clarification provided in the letter has raised up the ambiguity of academia on the applicability of Y-Category journals. To address this, the validity of journals along with benefits of each category are given below for clarification and implementation.
